LIMITED ONE (1) YEAR PARTS EXPRESS WARRANTY

Heat Controller warrants all parts of the 'C' Series Condensing Unit to be free from defects in workmanship and materials for normal use and maintenance for one (1) year from the date of purchase by the original consumer. This Express Limited Warranty applies only when the 'C' Series Condensing Unit is installed and operated per Heat Controller installation and operating instructions for normal use, and in accordance with all local, state and national codes.

LIMITED FIVE (5) YEAR COMPRESSOR EXPRESS WARRANTY

The compressor only is warranted to be free from defects in workmanship and materials for normal use and maintenance for a four additional years, for a total of five (5) years from the date of purchase by the original consumer. This five year warranty applies only when the system is installed and operated per Heat Controller installation and operation instructions for normal use.

COMMERCIAL USE-LIMITED ONE (1) YEAR PARTS WARRANTY

When the unit is put to commercial, business, rental, or any application other than residential use, the One Year Parts Limited Warranty as described in paragraph one is the only warranty that applies.

EXCEPTIONS

The Limited Express Warranty does not cover normal maintenance—Heat Controller recommends that regular inspection/maintenance be performed at least once a season and proof of maintenance be kept. Additionally, labor charges, diagnostic charges, transportation charges for replacement parts, replacement of refrigerant or filters, any other service calls/repairs are not covered by this Limited Warranty.
